



## TERMS AND CONDITIONS "\$10,000 FISH"



The following terms and conditions apply for the Grant Broadcasters "\$10,000 Fish" promotion on Hot91.1. These terms and conditions apply in conjunction with Grant Broadcasters General Contest Rules. Where there is any inconsistency, these terms and conditions will prevail.

### 1. DURATION

The active competition date is Sunday 25th September from 8am to 1pm OR until the winning fish is caught, whichever comes first.

### 2. METHOD OF ENTRY

Listeners are invited to register to participate in the \$10,000 Fish competition at [hot91.com.au](http://hot91.com.au). Late registration will also be available on the day. Only registered participants will be eligible for the \$10,000 prize. Registration is open to participants under 18, however only the nominated parent or guardian will be required to claim the prize on their behalf.

### 3. PRIZE

There will be one fish with the nominated winning tag on it. If caught during the designated contest period the registered participant will win \$10,000 which will be transferred into a bank account within 2 weeks of winning.

### 4. SELECTION OF WINNERS

The winner of the prize will be the first to present the tagged \$10,000 fish to a Davo's Tackle World representative on site, at The Noosaville Lions Park, on the day before 1pm on Sunday 25th September 2016.

### 5. NOTIFICATION

Prize winners will be notified on air at the time of winning. The winner will then be contacted by phone call to arrange collection of the Major Prize.

### 6. INDEMNITY

All contestants release from, and indemnify Grant Broadcasters against, all liability, cost, loss or expense arising out of acceptance of any prize(s) or participation in the competition including (but not limited to) loss of income, personal injury and damage to property and whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise.

### 7. ENTRY CONDITIONS.

Employees and their immediate families of are ineligible to enter. Employees and their immediate families of all associated sponsors and participating companies are also ineligible to enter. If after winners announcement a breach of eligibility is discovered, the prize will not be awarded.

### 8. SPECIAL CONDITIONS

The designated fishing area is between the Noosa Rivermouth and the entrance of Lake Coorobah, on the bank or in a boat.

The use of nets or other illegal fishing practices will result in instant dismissal.

If the tagged fish is caught outside of the contest period the prize is not valid.

Cheating or unsportsmanlike behavior will not be accepted and will result in instant dismissal from the contest.

Adherence to regular fisheries rules and regulations must be applied.

### 9. ALTERATION OF CONTEST SPOTS.

Grant Broadcasters reserves the right to alter or drop contest spots from the competition due to changed programming conditions in the event of a natural disaster or for any other unforeseeable reason.
